ORDER AND NOTICE OF HEARING ON FIRST DAY MOTIONS

On April 20, 2009, the above captioned Debtor commenced its Chapter 11 bankruptcy case by filing a voluntary petition for relief under Chapter 11 of Title 11 of the United States Code. The Debtor has filed the following denominated "first day motions" with the Court: (i) first day motion requesting authority to pay employee compensation and benefits; (ii) first day motion for interim order authorizing debtor to obtain post-petition secured and super priority financing, authorizing the debtor to use cash collateral, providing adequate protection, scheduling a preliminary hearing, and approving form and manner of notice; (iii) first day

motion requesting authority to continue use of existing bank accounts, cash management system, checks and business forms; (iv) first day motion to limit notice generally and establish certain case management and administrative procedures; and (v) first day motion requesting authority to pay pre-petition trust fund taxes (the "First Day Motions").

The Court: (i) pursuant to Local Rule B-9013-3; (ii) having reviewed the First Day Motions; and (iii) being otherwise fully advised in the premises, hereby sets a hearing on the First Day Motions, it appearing to the Court that good cause exists for setting the hearing and that one is required pursuant to Local Rule B-9013-3. Accordingly,

IT IS HEREBY ORDERED AND YOU ARE HEREBY NOTIFIED THAT:

The Court shall conduct a hearing in Courtroom 325, United States Bankruptcy Court, 46 E. Ohio Street, Indianapolis, Indiana, on the First Day Motions, and any objection thereto, on the **23rd day of April, 2009, at 2 p.m. EST**. All interested parties are welcome, but are not required, to attend the hearing.

Counsel for the Debtor is ordered to serve copies of the First Day Motions and this notice on all creditors and parties in interest as required by Local Rule B-9013-3(d), and file with this Court before the above hearing a certificate of mailing in respect of such service. Copies of the First Day Motions are also available, free of charge, at www.tucker-hester.com/caseinfo/redtop.

You may respond to any of the First Day Motions by filing a written response objecting thereto prior to the hearing with the Clerk of the United States Bankruptcy Court at the address indicated hereinabove and forwarding a written copy of said objection to Debtor's counsel: Jeffrey M.
